Defense Health Agency (DHA) / Medical Readiness Command-Alpha (MRC-A) | Joint Base San Antonio, TX

DHA: An integrated combat support agency with a global team of nearly 140,000 civilian and military personnel, serving 9.5M beneficiaries and supporting 700+ hospitals and clinics in the Military Health System, providing a medically ready force and ready medical forces.

MRC-A: Provides command and control of Air Force medical personnel delivering healthcare and readiness services. Organizes, trains, and equips personnel to generate Air Forces, responds to homeland contingencies, and delivers expeditionary care around the globe regardless of threat.

Director/CEO Defense Health Network Central | 2023 – 2025

Top executive of the DHA's largest healthcare network for 39 Air Force, Navy, and Army military medical treatment facilities employing 24,000 DoD personnel in 22 states, three countries, and one US territory across seven time zones; accounting for a quarter of all healthcare encounters within the DoD for 520,000 beneficiaries. Responsible for implementing policies aligned with Military Health System goals. Directly manages budgets, staffing, and medical resources to optimize healthcare delivery and operational readiness. Uses analytics to track healthcare trends. Responsible for improving patient outcomes while enhancing operational efficiency.

- **Provided strategic guidance and active management of a \$2.2B operational budget** including \$652 million in personnel/services contracts, 6160 civilian/non-Active-duty personnel payroll, \$284 billion/14 million square feet of real property and \$12.3 billion in equipment across the portfolio including a Level 1 trauma center and the DoD's premier burn center during a period of significant fiscal pressure and Congressional underfunding.
- **Visualized then realized a standardized business of medicine framework** consolidating 18 separate business databases with 22 prioritized high-level metrics which generated standardized reporting and tracking -- catapulting the system business operations from #6 to #1 of 9 DHA Networks in 10 months.
- **Facilitated medical affairs activities across the network** to produce 23 successful TJC commission surveys. In addition, 429 providers scored 100% on patient satisfaction surveys -- well above enterprise targets in the first 17 months of operations.

Commander/CEO, Medical Readiness Command-Alpha (MRC-A) | 2023 - 2025

Commands and controls 15K DoD personnel spanning four Air Force Major Commands and four Medical Wings. Supports Air Force Medical Command and Department of the Air Force Surgeon General by overseeing medical readiness programs, expeditionary medical capabilities, and readiness-related Department of the Air Force mission support requirements. Represents the Department of the Air Force in various interdepartmental, national, and international forums and agencies. Responsible for organizing, training, and equipping assigned personnel for air and joint operations at home and abroad. Collaborates with Air Force, Navy, and Army stakeholders to synchronize National Security efforts.

- **Led in the development and deployment of the Air Force Medical Command.** The multi-year process included inaugurating all initial policy guidance and procedures for operations of 33,000 global Air Force medical personnel in support of national defense strategy.
- **Forged unity of effort between two senior policy staffs** synergizing often competing interests between delivering health care to all beneficiaries while maintaining medical readiness and training.
- **Cultivated and maintained relationships with Senior DoD and Governmental leaders** across four Major Commands geographically dispersed around the globe from the East Coast of the United States to Korea, maintaining a cohesive and responsive medical support network.
- **Ensured the operational readiness of 552 deployable medical units of 3754 personnel** from 36 separate hospitals and clinics, directing adjustments to staffing and healthcare product lines often in response to short-notice requirements to send medics to global hot spots and humanitarian support.

Commander/CEO, 59th Medical Wing; Director, San Antonio Military Health System | 2023 - 2024

Commands the Air Force Medical Service's largest healthcare, medical education, and readiness platform comprising six units with a staff of 5,600 personnel executing a \$270 million budget. The wing conducts 900,000 clinic visits, performs 19,000 surgical procedures, and supports more than 300 worldwide deployments annually. Additionally, the 59 MDW staff at Brooke Army Medical Center supports 2.5 million patient visits and 19,000 admissions per year.

- **Drove operating room growth across the San Antonio Market**, leading two efforts maximizing the surgery scheduling and processes between main and ambulatory ORs, generating a 30% increase in monthly operating room volume and a 20% increase in utilization -- a six-year productivity high -- generating \$9.6M in revenue.
- **Responsible for a \$285M Air Force Medical Service (AFMS) training platform** pivoting to be on the cutting edge of medic training including a force generating global response capability with a \$5M just-in-time Aeromedical Evacuation/Patient Staging course.
- **Led the team to consolidate two clinics within the Market** optimizing resources and increasing access to specialty care by 30%.
- **Propelled an initiative across the Market to grow enrollment by 10%**, up to 73,000 enrolled beneficiaries, while also increasing Statement of Operations performance in family health, pediatrics, internal medicine, and women's health services by 55%.

An agency operating three geographically separated sites in Virginia, Maryland, and Texas that provides consultative leadership to over 44,000 personnel at 76 military treatment facilities and exercises significant influence over a \$6 billion budget. The agency supports and executes medical readiness programs, deployed capabilities with direct support, and implements policy, plans, and programs for the Air Force Medical Service.

Commander/CEO | 2021 – 2023

Served as chief executive officer managing a \$6.1 billion total budget and an over 500-person dispersed staff focusing on generating a trained and competent medical staff to deliver combat and humanitarian operations support worldwide.

- **Conceived and instituted the largest medical force posture structural change since the 1990s.** This 18-month, multi-disciplinary effort coordinated across Departments of Defense and Air Force reduced force structure complexity from 146 teams to 25 completely reimagined health services combat support to operate in contested environments; engineered for agility and postured on small teams capable of operating in a disaggregated manner.
- **Overhauled the \$1.2B supply chain, \$879M War Reserve Materiel (WRM) inventory** and \$60M annual WRM production plan enterprise to match agile combat employment requirements. Adjusted 14 Consolidated Storage and Distribution Centers (CSDCs) within AFMS to improve the flow of materiel into the battle space.
- **Orchestrated rapid crisis response and humanitarian support actions** positioning 400 medics and two mobile hospitals with \$14M in supplies in two geographic locations to treat 76,000 Afghans in less than 72 hours.
- **Led in national COVID Pandemic response operations** deploying 24 Air Force medical teams with 664 personnel to 33 civilian sites in addition to \$29M in personal protective equipment, \$4.6M in new medical lab equipment, and 824K infection tests to 89 bases worldwide.

The source of strategic guidance for a \$120 million medical modernization program.

- **Conceived then delivered on a two-year project creating an Accession Medical Waiver Division** endorsed by Air Force Vice Chief of Staff. Decreased medical decision variability, increased reliability and created robust data analysis for agile policy adjustments while accelerating 6,000 decisions on special duty flying waivers.
- **Realized \$3.9 billion in efficiency savings** by creating and guiding the transition team that mitigated 68 identified risks associated with the consolidation of all military healthcare systems into the \$60 billion Defense Health Program.
- **Replaced a legacy health-record-keeping system** with the \$5.5 billion Genesis upgrade by piloting training and delivering technical support across the entire Air Force medical treatment network.
- **Redefined the \$47 million portfolio** of research, development, and test-and-evaluation activities to better support medical study priorities by directing the realignment of 103 major projects in accordance with national defense strategy and closing capability gaps to ensure the best use of resources.

Command Surgeon/Regional VP | 2016 - 2018

Led five Divisions employing a \$1.3 billion budget and executing healthcare delivery in 16 facilities for 300K beneficiaries in four states. Responsible for training oversight for 43K Air Force medical personnel annually. Senior advisor to the Air Education and Training Commander on all health-related issues.

- **Generated an astounding 58% increase in the preceding year's production** and the largest accession volume since the Vietnam war by completely revamping medical accession production and meeting increased Air Force manning requirements.

- **Led the hospital to #1 in the DoD**; the only military facility ranked in the top 10% of all U.S. hospitals for inpatient satisfaction, securing Congressional support for a \$74M facility upgrade and genetic lab expansion.
